Pico Neighborhood Association MANGO SURVEY

The Michigan Avenue Neighborhood Greenway (MANGO) is intended to create an inviting streetscape along Michigan Avenue between 7th and 20th and the adjoining streets through beautification and measures that would possibly result in traffic reduction. This can be achieved by installing traffic calming measures, upgraded landscaping, sidewalk improvements, bike facilities, and enhanced crosswalks. The goal is to provide a safe and comfortable place for neighbors of all ages to walk, bike, relax and interact with one another. Having a neighborhood Greenway will make it easier to get around the Pico Neighborhood on foot and by bicycle. It will serve to connect residents and visitors with schools, job centers and future Expo stations, improve the quality of our environment and enhance the livability of the Pico Neighborhood.

We have been assured by the City staff that there will be no Cycle Tracks and no significant loss of parking on Michigan Ave. from Lincoln Blvd. to 19th Court.

The PNA is working with the City of Santa Monica to ensure that the proposed *Michigan Avenue Neighborhood Greenway (MANGO)* reflects the wishes of Pico Neighborhood residents.
